2022 Saw Enhancements to MTEF Programming

The Milwaukee Tennis & Education Foundation is a Wisconsin 501(c)(3) nonprofit corporation devoted to building the lives of at-risk youngsters one child at a time.

Founded in 1975 as a vehicle to preserve and promote the game of tennis in Wisconsin, the foundation primarily has focused its efforts on its central-city outreach and community tennis programs since 2002 when it absorbed the Milwaukee Community Tennis Association.

Although MTEF had offered outreach sessions involving tennis and education since 1995, it was not until 2001, when a \$31,000 grant from Miracle on Canal Street initiated the exponential growth TEAM has experienced since then.

MTEF is the Greater Milwaukee area's official National Junior Tennis and Learning (NJTL) chapter as well as the city's community tennis organization.

As of 2022, MTEF had received numerous national and regional awards for its programming, which emphasizes reading, life skills and nutrition/fitness in addition to tennis.

Among the honors, MTEF was rated, out of the then-more than 500, the No. 1 NJTL chapter in the country by the USTA in 2011 and the No. 2 in 2012.

It also is one of a handful organizations to continually receive the USTA's four-star rating, the highest a chapter can achieve.

In 2022, MTEF's summer programming introduced some new efforts under the leadership of Executive Director Rachael Badt, who assumed the post in the fall of 2021.

Summer campers had the opportunity to explore not only tennis but golf and soccer as well when the foundation partnered with First Tee Southeast Wisconsin and America Scores for *Get in the Game Field Trip Days*. MTEF kids met with kids from three Milwaukee public schools, Silver Spring Neighborhood House and Neu Life at Noyes Park where the youngsters engaged in all three sports.

MTEF's Merrill Park Summer Camp added a new and adventurous component when the foundation became a partner

with the Albert and Ann Deshur JCC Rainbow Day Camp in Fredonia. The program, Road to Rainbow, is funded by the JCC and gives underserved children a chance to experience a rural day camp. Each camper spent one week of each three-week session at the camp, enjoying tennis along with regular camp activities such as archery, wall climbing and swimming.

A half-day summer camp, featuring many of the same activities offered at Merrill Park, was held at Brown Deer High School in partnership with Brown Deer Parks and Recreation.

In addition, two teams from MTEF participated in the 2022 Wisconsin Junior Team Tennis summer championships in Sun Prairie. The Slammers competed in the tournaments US Open Division while the Aces played in the Wimbledon Division. Although MTEF didn't win, a lot of fun was had by all during a great tournament experience.

MTEF's third Serve & Connect Day was held at Sherman Park. The community event provided attendees an opportunity to meet one-on-one with first responders in a variety of fun activites and included a cleanup of the park grounds. Needless to say, some of the day's programming involved the particiants hitting some tennis balls in a friendly, non-competitive atmosphere.

In mid-September, MTEF staged its Second Annual Pickleball & Tennis fundraiser at North Shore Country Club in Mequon. Participants could choose to play either sport before enjoying a taco buffet. The brainchild of Mike Sperling, a board member and former president, the event raised close to \$2,400 to support MTEF activities.

But the top highlight of the year proved to be the foundation's 23rd MTEF Tennis Ball. Held Nov. 12 at the Italian Community New activities at the Ball included a gift card pull, a basket challenge game and a caricaturist, who dew sketches of ballogers throught the evening,
