As COVID Waned, Programming Took Forward Steps

The Milwaukee Tennis & Education Foundation is a Wisconsin 501(c)(3) nonprofit corporation devoted to building the lives of at-risk youngsters one child at a time.

Founded in 1975 as a vehicle to preserve and promote the game of tennis in Wisconsin, the foundation primarily has focused its efforts on its central-city outreach and community tennis programs since 2002 when it absorbed the Milwaukee Community Tennis Association.

Although MTEF had offered outreach sessions involving tennis and education since 1995, it was not until 2001, when a \$31,000 grant from Miracle on Canal Street initiated the exponential growth TEAM has experienced since then.

MTEF is the Greater Milwaukee area's official National Junior Tennis and Learning (NJTL) chapter.

As of 2021, MTEF had received numerous national and regional awards for its programming, which emphasizes reading, life skills and nutrition/fitness in addition to tennis.

Among the honors, MTEF was rated, out of the then-more than 500, the No. 1 NJTL chapter in the country by the USTA in 2011 and the No. 2 in 2012.

It also is one of a handful organizations to continually receive the USTA's four-star rating, the highest an NJTL chapter can achieve.

In 2021, MTEF's programming, which had been curtailed by COVID the year before, returned to what could be referred to as relatively nornal.

Events that had been cancelled reappeared, including the annual Serve & Connect Day and the MTEF Tennis Ball. They were joined by a new fundraising event, the Pickleball and Tennis Benefit.

Serve & Connect Day, is a program that brings MTEF participants and their families together with representatives of the Milwaukee Fire and Police Departments and community residents. The annual agenda includes a cleanup of Milwaukee County's Sherman Park, where MTEF's headquarters is located, along with some fun on-court tennis and a picnic lunch.

Held for the first time at the Italian Community Center, the 22nd Annual MTEF Tennis Ball was a resounding success, drawing a crowd of 260 and netting \$77,000 to support the foundation's programming.

The mid-September Pickleball & Tennis fundraiser, organized by Mike Sperling, an MTEF board member, was deemed not only great fun but also successful enough to become an annual event. The first edition, which raised \$3,200, took place at North Shore Country Club in Mequon.

MTEF continued — both virtually and, where possible, inperson — that focus on both the physical and social-emotional wellbeing of its participants, including trauma-informed programs in partnership with Stryv365.

The 2021 Summer Camp featured Mentor Monday sessions with speakers such as former USTA President Katrina Adams, Milwaukee's newly appointed Fire Chief Aaron Lipski and Assistant City Attorney Anthony Jackson along with a variety of new activities designed to make the summer camp a really fun experience. It wrapped up with the traditional TEAM Cup tournament.


MTEF also continued its summer partnerships with the Milwaukee Recreations Department, Brown Deer schools and the Brown Deer Parks and Recreation Department.

In fall, year-round participants were introduced to circuit training that honed their tennis skills without the need for a court. Held Tuesday evenings in the gym at the Silver Spring Neighborhood Center, the program brought together players of different ages and in different stages of their tennis journey as they worked at a series of stations that helped them improve their serves, volleys and overheads.


